The Democracy Protection Network is a coordinated network of experts who have come together to provide support for civil society organizations and individual leaders who are increasingly facing a variety of threats that drain resources and detract from their core work. Our broad goal is to ensure that those who are targeted are able to stay on the field. The DPN coordinates low- to no-cost crisis-response and resilience-building services — including physical security, cybersecurity, crisis communications, and legal services — for organizations and individuals working to protect and strengthen American democracy.

The DPN is able to support some current and former government officials who are singled out in some way and face an immediate threat. We understand, though, that the current need is far greater than that. We offer these self-serve resources as a starting point for civil servants looking to better understand their rights and options. Also, the DPN recently published a more comprehensive set of *Readiness and Resilience-Building Resources* for civil society, including cybersecurity, legal compliance, physical security, and crisis communications resources that may be helpful to current and former civil servants as well as others.
